To whom it may concern,

Hereby We provide Our reply to "Letter to Mr. Slade 9.11.2017" sent to Us via email on 9/11/2017.

Ad Paragraph 1

The contents of this paragraph are noted. We refer to your letter dated 03 November 2017, Our response thereto of 06 November 2017, the subsequent telephonic conversation between Justus Heerden and Us on 07 November 2017 and your letter dated 9/11/2017.

Ad Paragraph 2

We confirm that you notified Us that your client is unable to attend the intended proceedings during the week of 21st November 2017; when We were notified for the first time that Kevin Richardson was unavailable by one of *Weavind & Weavind's* employees, Jarik Jansen, We asked him to submit a written expert testimony instead. We want to draw your attention to the fact that the proceedings in the Equality Court are mostly informal and that not even the court clerk in Ubombo Magistrate's Court is familiar with them. We were not required by the law to have a legal representation, and it is reasonable for Us to not know the exact rules, including the ones pertaining to witness subpoenas, and therefore not comply with them.

Ad Paragraph 3 - 8

The contents of this paragraph are noted.

Ad Paragraph 9

We deny what you record in this paragraph; We record that We sent a notice dated 25/8/2017 to your client, Kevin Richardson, giving him a choice to come on his own free will or being subpoenaed automatically, before We requested the court to issue a subpoena for him. We thought he might have wished to assist the court in solving this case once for all and help Us prove the fact with the objectivity and honesty of an expert animal baviourist. As We received no response whatsoever from your client, We did continue with the subpoena process.

On 10/10/2017 your Jarik Jansen informed Us about Kevin Richardson's unavailability for the first time, asking for his excuse. The following day We confirmed the excuse of Kevin's testimony in court on the condition that he gives us a written expert testimony based on the questioning that he would have faced in court. Jarik kindly agreed that We send him the document with the statements to be validated by Kevin, which also served to clarify the relevance of your client's expertise on this matter.

The accusations in this paragraph are false; it stands to be questioned if your client does not have *Mala Fide* towards Us. Kevin's public statements referring to My husband Andre Slade are

unacceptable and very damaging as Andre did everything in Good Faith only and according to *God's Law* and *The Constitution of South Africa*, applying, inter alia, His right to freedom of belief, conscience, culture, opinion and association. He is honourable man respected by Our Black neighbourhood and the attacks on Him are in fact a big offense. My Husband has no bad intentions and I request that you give Him due respect and do not continue to damage His name. He is The Son of God, Yahshuah, the direct offspring of King David and He does exactly what Our Family Law dictates to do. He is the true Lion King; His only "crime" is speaking the truth.

Ad Paragraph 10

We admit that We were not familiar with the exact rules regarding the witness subpoena: We did not expect such a high fee to be demanded by your client as We thought he could be passionate about the science/biology and might be willing to assist Us for the greater good. We confirm that We do not have any income and that the amount required by your client is not affordable to Us. However, We were willing to cover his costs.

Ad Paragraph 12

The contents of this paragraph are denied.

Ad Paragraph 13

Your client is hereby excused from testifying at the proceedings set to commence on 21st November 2017; however, We kindly ask your client Kevin Richardson known as The Lion Whisperer, to submit his objective expert testimony in a written form. In case he does not do so, We ask him to give Us a reason for not doing so in writing to clarify it to the court.
