1.

My title is Enki and My Avatar's name is Yahshuah. I am acting agent on behalf of the Trust of ANDRE MARTIN SLADE. I am a 56-year-old Hebrew Man from the Royal tribe of Judah, who has been a resident on the premisses since July 2007. Address: Sodwana Bay Main Road, Mbazwana, Kwa-Zulu Natal. Post: P. O. All facts contained in this affidavit are to the best of My knowledge and belief both true and correct unless otherwise indicated. I represent the First Respondent in this matter. I also refer to My Wife and I as Us/Our/We. Where applicable, the word meaning (etymology) and/or definition was quoted from Dictionary.com, Etymonline.com, Merriam-webster.com and Thelawdictionary.org and Black's Law Dictionary. I am competent to depose to this affidavit.

The **emphasis** in this affidavit is Mine to stress the importance of a statement.

3.

For the purpose of this affidavit I would like to outline some of My character traits through excerpts taken from My character analyst's report. I am described as: "a gentle, sensitive person with a



deep understanding of people and a very tolerant, accepting, nonjudgemental approach towards life" and "you are not an aggressive, forceful person, and you intensely dislike conflict." My real motivation is interacting with people and creativity. I "have an unbiased mind and I have the ability to offer a fresh clear uncluttered perspective". Discrimination is not amongst My strong points. " I am also "very compassionate and cannot tolerate seeing a fellow creature suffer – be it human, animal or even plant!..."

4.

I am a laser electronics Specialist by trade (Annexure 1), a passionate mechanical draftsman/designer/developer, self-taught CNC (Computer Numerical Control) programmer/operator and a product prototype and development technician for which I have been awarded a South African Bureau of Standards Design Award for Mechanical Design Excellence (Annexure 2). As dive instructor and underwater videographer/photographer I've worked actively in the filming industry. I was awarded an International Wildlife Photography Award for Underwater photography (Annexure 3). As national serviceman I was an Instructor Corporal and bear a Pro-Patria medal for border duty (Annexure 4). I am the founder of *Inner Space Developments*.

5.

I started *Inner Space Developments* in 1995 as sole proprietor based on demand for an underwater video camera housings system I had developed, eventually offering a 3D product development and prototyping workshop as a low production facility while manufacturing My own product. I designed and built the house on the premises primarily as home with My workshop attached to it because research & development takes a lot of time and dedication, including working till late at night.

6.

But most importantly, I am the author of the book of ABSOLUTE TRUTH called *Where to from Here: Cognition*, which I co-authored with Katarína Križáni. It is the little book prophesied in



The Bible to be published in these times to finally reveal the mystery of God; its building blocks are derived from all major doctrines and disciplines. Together We as The Two Witnesses of God have been tasked by Almighty God YAHWEH to found His New Qingdom/Heavenly Kingdom on Earth which is the opposition to the New World Order currently unfolding.

7.

As mentioned/explained in the Applicant's Annexure G2, I was lead by the higher power/God to stop caring for material wealth and instead to focus all My attention on finding the truth and to write about it. This ignited My extensive research into so many various disciplines with deep desire of arriving to a universal truth which could be verified/validated as well. While I was conducting the research, I also decided to start developing a free energy device partly based on the works of the great genius Nikola Tesla instead of My underwater products. His work was very relevant to My research. ESKOM was not reliable and I was working towards going off the grid so I saw a tremendous need for and great potential of such a device. Various free energy generators have already been successfully tested. This was the reason why *Inner Space Developments* was made dormant in 2010.

8.

My focus had totally changed, and the Guest House generated enough money to sustain Us while writing the book. Shortly after We closed the Guest House in 2016, all development work was halted. We have survived to present day from the sales of My hi-tech workshop equipment, donations mostly from the Krizani family and occasional help in the form of produce from our "zulu" neighbours.



9.

Section 34 of the Bill of Rights states: "Everyone has the right to have any dispute that can be resolved by the application of law decided in a fair public hearing before a court or, where appropriate, another independent and impartial tribunal or forum."

All legal professions [profession (n.) c. 1200, "vows taken upon entering a religious order"] are subservient to the Roman Catholic Church. Judges, lawyers and advocates have all sworn allegiance to The Queen of England who herself is subject to the Pope; therefore they are in conflict of interest. We are actively opposing Roman Catholic dominance and authority (Annexure 5). To uphold Actus Regis Nemini Facit Injurim and in the interest of true justice We demand at the very least a jury.

We want to emphasise that the Roman Catholic Church and its legal system/ the maritime law is the sea beast from The Bible empowered by the Satan that sees human beings as monsters:

Ballentine's Law Dictionary (1930) defines human beings as following:

"**human being** - See **MONSTER**.

Monster: A human being by birth, but in some part resembling a lower animal. A monster hath no inheritable blood, and cannot be heir to any land.

Such a contempt for human beings is confirmed in Black's Law Dictionary:

"MONSTER

A prodigious birth; a human birth or offspring not having the shape of mankind, which cannot be heir to any land, albeit it be brought forth in marriage. Bract fol. 5; Co. Litt. 7, 8; 2 Bl. Comm. 246."

11.

In the light of the above and as per **Section 33 rule 1. of the Bill of Rights** We represent Ourselves in court. We however have to draw the court's attention to the fact that on 20/06/2014 the High Court in Durban acknowledged receipt of Our *Supersedeas Peremptory Writ of Mandamus* segregating Us from the corporate structure (Annexure 6).

12.

We are the owners of the house formerly operating as Sodwana Bay Guest House. According to SARS: "A sole proprietorship is a business that is owned and operated by a natural person (individual)" meaning that the person is not affiliated or associated with Corporation. As a Free Man on the land, trading accommodation for cash is a constitutional right as per **Rule 22 of the Constitution of South Africa**.

We declared Our right of association as per **Rule 18 of the Constitution of South Africa**. We did not deal with government inspired tourism because We are not part of the Corporation. The documents are on public display on Our blog at <http://wheretofromhere.org/>. The Guest House was closed by Us following the incident of 22/06/2016, and the Umhlabuyalingana municipality was notified about it during an inspection done in August 2016.

13.

I now provide a seriatim reply to the allegations in the Applicant's founding affidavit. Any allegation in the Applicant's affidavits which is not specifically addressed in this affidavit is denied.



14.

RESPONSE TO THE APPLICANT'S AFFIDAVIT

Ad paragraph 10

The First Respondent takes notice of the contents of the paragraph.

Ad paragraph 10

I concur that the Applicant is the registered owner of the land; however We dispute the validity of this registration.

Ad paragraph 11-24

The contents of these paragraphs are noted.

Ad paragraph 25 -28

The sheriff of Ubombo never delivered the notice of termination of the lease to Us and has already been reported to the Sheriff's Board for corruption and incompetence with no resolve so far. We were notified about the cancellation of the contract by the Applicant only through the Applicant's Notice of Motion delivered to Us on 9/ 4 /2019 by a different sheriff. I want to bring to the attention of the court that already in or about 2014 I vehemently stated to the Applicant's accountant who contacted Me regarding My non-payment that I was not going to pay any longer and that they could start their court proceeding as I wanted to resolve the issue openly.

Ad paragraph 29

The contents of this paragraph are noted.



Ad paragraph 30

We are living on these premisses primarily on the basis of a PTO which is "permission to occupy" granted by the Mabile Tribal Authority and the neighbours of the "zulu" tribe We live among prior to the lease being signed. The original contract states that We have Our home on these premisses as well. As the tribal authority has more power than corporate law, therefore; if there was anyone who could revoke Our occupation of this rural piece of land We call home, it would be them rather, but then there will be a jury.

Our "Induna" Patric Jabulani drove in to ask to help his kids with a school subject recently and was notified about the Applicant's intentions to evict Us; his words in reply were: "They can't do that; you live here!".

Ad paragraph 31

Above and beyond the fact that it is unprofessional and biased to refer to Our other cases in an effort to discredit Us thus negatively influencing your court's perception of Us, We have offered humanity all the proof needed to validate Our claims/My identity and confirm the biblical truth We have exposed. It is however up to everyone concerned to evaluate the solid body of evidence presented in detail. As a matter of fact, We also decided to refuse to accommodate half-breeds, prostitutes and the homosexual community. This segregation is required by God and is stated in The Law as follows:

"And ye shall be holy unto me: for I the LORD am holy, and have severed you from other people, that ye should be mine".

Leviticus 20: 26

I am therefore not going to indulge in the scientific evidence that was refused by the so-called Human rights commission and the Magistrates court of Ubombo at the end of Our Equality case. The evidence will be handed in during Our appeal. We are not what the media and ANC have made Us out to be. We are the Two witnesses of God.



Ad paragraph 32

In light of My statement "You are classified in The Bible as an animal, you are not homo sapien.":

It is not just My view but an easily provable scientific fact. Because this case is not the Equality court case, I herewith briefly provide the following facts:

1) Taxonomy, the science of naming, describing and classifying organisms classifies Homo genus (which includes both whites and blacks) as part of the Animal Kingdom.

2) An word animal is described as: "1. (zoology) any living organism characterised by voluntary movement; 2. any mammal, esp. any mammal except man" or "3. a brutish or beastlike person".

The literal meaning (etymology) of the word animal is living soul/ having life.

In fact The Bible refers to blacks as the beasts of the field; The Creator divided/separated Homo genus into four groups: Yahudim (The tribe of Judah), Yahsharal (The tribes of Israel), Man (Caucasians) and Beast (Blacks):

"Behold, the days come, saith the LORD, that I will sow the house of Israel and the house of Judah with the seed of man, and with the seed of beast."
Jeremiah 31:27

"**beast** (n.)c. 1200, beste, "one of the lower animals" (opposed to man), "a brutish or stupid man," from Old French beste "animal, wild beast," figuratively "fool, idiot" (11c., Modern French bête), from Vulgar Latin *besta, from Latin bestia "beast, wild animal,".

The following signifies the correctness/validity of the above:

South Africa rates in the world as one of the most dangerous countries to visit because of its prevalent crime, aggression, violence, rape (including even rape of babies and domestic animals), corruption, escalating over-population, bestiality, cannibalism, black magic and low regard for life.

We collected daily newspaper clippings from *Zululand Observer* as proof of this; these newspaper articles are part of Our evidence to be submitted for the Equality Case.

Ad paragraph 33

The propaganda spread by media has been proven to be biased and deceitful. Media does not uphold the principle of truth and justice any more. They are also subject to the private Corporation's rules of conduct. "Racism" is purposefully used against white South Africans and other whites around the globe to suppress them and keep them submissive; while "blacks" as Julius Malema are protected even if he suggests killing White people in South Africa. This shows pure bias from the legal system. "Racism" is a communist strategy to suppress God's people, and Equality principle is set to destroy the Royal bloodline of The Yahudim, God's Chosen nation.

Ad paragraph 34

The contents of this paragraph is noted.

Ad paragraph 35

Jobe Nokukhanya, the clerk of the Ubombo Magistrate's Court confirmed to Us on 23/4/2019 that Our Equality court case is in the process of appeal to High Court which means the Judgement has not been finalised and the case needs to be treated as an open case.

Ad paragraph 36

We want to draw court's attention to the fact that the Applicant is trying to utilise the abovementioned Court Judgement (Applicant's Annexure K) as the basis for Our character



description despite the fact that the case is currently in the process of appeal and thus still remains an open case as mentioned above.

36.1 – 36.4 The contents of this paragraph are noted.

36.5- 36.6 The contents of this paragraph are admitted except for the fact that Katarina is not just My girlfriend but My Wife /My twin flame meaning She is My exact equal opposite, My other half, and We are one. I agree with the magistrate's assessment that Katarina should be accused and be a party in the Equality case proceedings. We are married under Divine Decree which is spiritual in nature. We consider Ourselves as one and speak as such as noted by the Magistrate in his final speech after the equality case.

36.7 I bring into court's attention the fact that the Magistrate openly complemented Our work:

"One can say they are a couple made in heaven as both sing from the same hymn sheet regarding their views on Blacks (Applicant's Annexure K, pg 163, line 7 -9).

"Definition of idiom ***made in heaven***: very good and successful".

Our work is very good and successful only because it is inspired by God the Father:

"If I do not the works of my Father, believe me not. But if I do, though ye believe not me, believe the works: that ye may know, and believe, that the Father *is* in me, and I in him." (*John 10:36- 37*)

36.8 The contents of this paragraph is admitted.

Ad paragraph 37

37.1 We deny the contents of this paragraph; the Applicant's Annexure G2 illustrates clearly the reason why.



INGONYAMA TRUST as a "legal fiction" that does not exist, is not in charge of and therefore does not have the authority over the Tribal court. We have permission to occupy this land from YHWH, Our community and the Tribal court.

37.2 Yes, My Wife and I live in Our private house on the premisses.

37.3 We have God-given right to occupy this land, and the Mbile Tribe has not terminated Our occupation of this land nor have the members of the tribe demanded from Us to leave.

Ad paragraph 38

I deny the contents of this paragraph. INGONYAMA TRUST is a private corporation which I am not a subject of. It therefore has no right to interfere with Me or anyone else living on the land; I need to draw court's attention to the case against the Applicant which demonstrates the general dissatisfaction, opposition and the rebellion against the Applicant by the Zululand community (Annexure 7 and 8).

Ad paragraph 39

I admit the contents of this paragraph and wish to point out the emphasis:

"4.(7) If an unlawful occupier has occupied the land in question for more than six months at the time when the proceedings are initiated, a court may grant an order for eviction if it is of the opinion that it is just and equitable to do so, after considering all the relevant circumstances.

Ad paragraph 40

The contents of the paragraph are correct.

Ad paragraph 42

Ad paragraph 43

I deny the contents of this paragraph;

Firstly, I have God-given right to occupy the premises, as I mentioned before.

Secondly, as stated in Our letter (Applicant's Annexure G2) to "Zulu King" Goodwill Zwelithini, he would be privileged to return the stolen Zulu Kingdom to The True Zulu King/The Lion of Judah (The Lion King) and receive the True Zulu wisdom as his "zulu" tribe has been "worshipping" The Heavenly/Sky God for a long time. The following verse from The Bible shows the exclusivity of The Yahudim/Judeans also known as Jews:

"Thus saith the LORD of hosts; In those days *it shall come to pass*, that ten men shall take hold out of all languages of the nations, even shall take hold of the skirt of him that is a Jew, saying, We will go with you: for we have heard that God is with you."

Zechariah 8:23

Thirdly, before the incident of 2016, I was pumping about 10 000 litres of water for Our neighbours every day for years. The ANC supplied a 5000 litre tank which We filled up to twice a day. Shortly before 22 June 2016, Our borehole pump was stolen so We could not supply the neighbours any longer and ANC wanted their drum back even if the "zulu" community won't have water. I need to point out that the fact that communal pump was stolen despite it causing whole community a big challenge shows true contempt they have for each other and anyone else. I hereby want to draw the court's attention to the autographed testament provided by Our house servant Slindile Mthiyane (Annexure 9) and the letter Our neighbours autographed in Our support following the "no blacks" saga (Annexure 10) which both prove that We love Blacks.

I admit the contents of this paragraph.

Noted.

Ad paragraph 46

Thank you for the advice, but We are not looking for accommodation; We like living here because God brought Us here amongst the "Zulu Tribe" that served The Zulu Kingdom.

Ad paragraph 47

I deny the contents of this paragraph.

The contents of this paragraph are noted.


Ad paragraph 50

APOSTOLIC LETTER
ISSUED *MOTU PROPRIO*

OF THE SUPREME PONTIFF
FRANCIS

ON THE JURISDICTION OF JUDICIAL AUTHORITIES OF VATICAN CITY
STATE
IN CRIMINAL MATTERS

In our times, the common good is increasingly threatened by transnational organized crime, the improper use of the markets and of the economy, as well as by terrorism.

It is therefore necessary for the international community to adopt adequate legal instruments to prevent and counter criminal activities, by promoting international judicial cooperation on criminal matters.

In ratifying numerous international conventions in these areas, and acting also on behalf of Vatican City State, the Holy See has constantly maintained that such agreements are effective means to prevent criminal activities that threaten human dignity, the common good and peace.

With a view to renewing the Apostolic See's commitment to cooperate to these ends, by means of this Apostolic Letter issued *Motu Proprio*, I establish that:

1. The competent Judicial Authorities of Vatican City State shall also exercise penal jurisdiction over:

A handwritten signature in black ink, appearing to be 'Francis', located in the bottom right corner of the page.

- a) crimes committed against the security, the fundamental interests or the patrimony of the Holy See;
- b) crimes referred to:
- in Vatican City State Law No. VIII, of 11 July 2013, containing *Supplementary Norms on Criminal Law Matters*;
 - in Vatican City State Law No. IX, of 11 July 2013, containing *Amendments to the Criminal Code and the Criminal Procedure Code*;
- when such crimes are committed by the persons referred to in paragraph 3 below, in the exercise of their functions;
- c) any other crime whose prosecution is required by an international agreement ratified by the Holy See, if the perpetrator is physically present in the territory of Vatican City State and has not been extradited.
2. The crimes referred to in paragraph 1 are to be judged pursuant to the criminal law in force in Vatican City State at the time of their commission, without prejudice to the general principles of the legal system on the temporal application of criminal laws.
3. For the purposes of Vatican criminal law, the following persons are deemed "*public officials*":
- a) members, officials and personnel of the various organs of the Roman Curia and of the Institutions connected to it.
 - b) papal legates and diplomatic personnel of the Holy See.
 - c) those persons who serve as representatives, managers or directors, as well as persons who even *de facto* manage or exercise control over the entities directly dependent on the Holy See and listed in the registry of canonical juridical persons kept by the Governorate of Vatican City State;

- d) any other person holding an administrative or judicial mandate in the Holy See, permanent or temporary, paid or unpaid, irrespective of that person's seniority.
4. The jurisdiction referred to in paragraph 1 comprises also the administrative liability of juridical persons arising from crimes, as regulated by Vatican City State laws.
 5. When the same matters are prosecuted in other States, the provisions in force in Vatican City State on concurrent jurisdiction shall apply.
 6. The content of article 23 of Law No. CXIX of 21 November 1987, which approves the *Judicial Order of Vatican City State* remains in force.

This I decide and establish, anything to the contrary notwithstanding.

I establish that this Apostolic Letter issued *Motu Proprio* will be promulgated by its publication in L'Osservatore Romano, entering into force on **1 September 2013**.

Given in Rome, at the Apostolic Palace, on 11 July 2013, the first of my Pontificate.

FRANCISCUS

Be pleased to take further notice that we comprehend and declare the *Motu Proprio* to mean the following:

Exposition of facts

- [1]. All employees of corporations, all of which are established under the Roman Curia, are no longer immune. Therefore, **ALL** employees of **BAR** courts, governments, law enforcement, banks, collection agents, SARS, SARB, etc., as of September 1st, 2013, are and will be held accountable for crimes against humanity when the will and wish of we, the people is vexatiously



dismissed, which includes failure to uphold the law of the land when requested to do so;

[2]. *3. For the purposes of Vatican criminal law, the following persons are deemed "public officials": [former "private officials" exempt from law are now within the laws dictates and are held liable, aka "public servants"]*

a) *members, officials and personnel of the various organs of the Roman Curia and of the Institutions connected to it. [World-wide corporations and all individuals in trust are corporations pursuant to their birth certificate]*

b) *papal legates and diplomatic personnel of the Holy See. [The Pope governs the Church/people/trust, all the people in the Birth Trust, through the Roman Curia, the governing body of the Vatican and *Unum sanctum*]*

c) *those persons who serve as representatives, managers or directors, as well as persons who even de facto manage or exercise control over the entities [public servants] directly dependent on the Holy See [trust beneficiaries] and listed in the registry [through birth certificates] of canonical juridical persons [legal fiction represented by a birth certificate ALL CAPS NAME] kept by the Governorate of Vatican City State;*

d) *any other person holding an administrative or judicial mandate in the Holy See, permanent or temporary, paid or unpaid, irrespective of that person's seniority. [all public servants]*

[3]. *4. The jurisdiction referred to in paragraph 1 comprises also the administrative liability of juridical persons arising from crimes, as regulated by Vatican City State laws. [public servants are now liable for crimes against humanity]*

[4]. *I establish that this Apostolic Letter issued Motu Proprio [on his own impulse] will be promulgated by its publication in L'Osservatore Romano, entering into force on 1 September 2013. Given in Rome, at the Apostolic Palace, on 11 July 2013, the first of my Pontificate.*

[5]. **Synopsis:** Church = People = Trust



The Vatican created a world trust using the birth certificate to capture the value of each individual's future productive energy. Each state, province and country in the fiat monetary system, contribute their people's value to this world trust identified by the SS, SIN or EIN numbers (for example) maintained in the Vatican registry. Corporations worldwide (individuals became corporate fictions through their birth certificate) are connected to the Vatican through law (Vatican to Crown to BAR to laws to judge to people) and through money (Vatican birth accounts value to IMF to Treasury (Federal Reserve) to banks to people (loans) to judges (administration) and sheriffs (confiscation)).

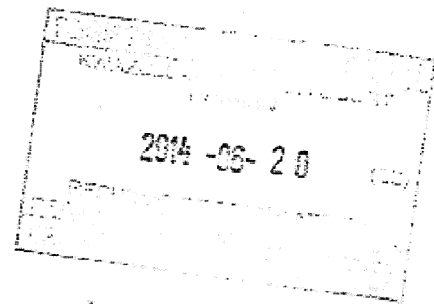

Zulu king slapped with lawsuit over land in KZN

Zulu king Goodwill Zwelithini, who is embroiled in a legal wrangle with racist guest house owner Andre Slade over the payment of rental arrears for the land on which he lives, has now been slapped with court papers in a bid to compel him to stop forcing occupiers of land under Ingonyama Trust to pay rent.

The Zulu monarch was served with court papers by the Legal Resources Centre (LRC) on Tuesday. The LRC filed an application in the Pietermaritzburg High Court on behalf of the Council for the Advancement of the South African Constitution (Casac), the Rural Women's Movement and seven informal land rights holders.

They are challenging the conversion of Permission to Occupy (PTO) or informal land rights to long-term lease agreements by the Ingonyama Trust. A number of people hold a PTO or informal land rights on land vested or registered under the Ingonyama Trust.

The trust, which administers 2.8-million hectares of land on behalf of King Zwelithini, who is the sole trustee, was established in 1994 to be the custodian of the land previously administered by the former KwaZulu-Natal government.

In November last year, the trust published adverts in various newspapers in KZN inviting holders of PTOs to approach the Ingonyama Trust Board "with a view to upgrading these PTOs into long-term leases in line with the Ingonyama Trust tenure policy".

But in court papers, the applicants argue that the trust acted "unlawfully and in violation of the Constitution" by cancelling PTOs and concluding lease agreements with the holders of PTO rights or informal land rights.

Casac secretary Lawson Naidoo said in his affidavit that since 2007 the trust and its board have been "undermining the security of tenure of residents and occupiers of trust-held land in KwaZulu-Natal".

He also accused the trust of "extorting money from them by unlawfully compelling them to conclude lease agreements and pay rental to the trust to continue living on the land".

In a related matter, Slade – who in 2016 shot to infamy by refusing to accommodate black people at a guesthouse in northern KZN, and by making multiple racist comments in the aftermath - was served with a letter of demand in April by the Ingonyama Trust Board, demanding the immediate payment of R62,584 in rental arrears for the land on which he lives.

However, Slade said the board had picked a "royal fight" and refused to pay the rental fee because he and his Slovak lover Katarina Krizaniova didn't recognise Zwelithini's authority as king.

"In the name of Yahweh, almighty God, we refuse to recognise and respect the so-called Zulu king. King is God's title, yet the first commandment of God says 'thou shall not have no other gods before me'," he wrote on his website.

But the Zulu king has threatened to push for KwaZulu-Natal to secede should the government implement the panel's recommendations and has warned strongly against any attempts to dissolve the trust.

Last month auditor-general Kimi Makwetu took issue with the Ingonyama Trust board for failing to provide supporting documents to account for land to the value of R1.08bn.

Board chairman Judge Jerome Ngwenya said they were not aware of any case against trust, but would appose it.

King Zwelithini's trust needs more time to deal with lawsuit over land

Goodwill Zwelithini's Ingonyama Trust Board may be forced to pay back millions of rands it has unlawfully collected in rent for nearly a decade from people living around KwaZulu-Natal.

The Ingonyama Trust Board (ITB), which may be forced to pay back millions of rands it has unlawfully collected in rent for nearly a decade from people living on land it controls on behalf of Zulu King Goodwill Zwelithini, needs more time to respond to a legal challenge.

The trust, which administers 2.8-million hectares of land on behalf of the Zulu monarch, had until the end of January to respond to an application filed by the Legal Resources Centre (LRC) in the Pietermaritzburg High Court in November on behalf of the Council for the Advancement of the SA Constitution (Casac), the Rural Women's Movement and seven informal land rights holders.

However, SowetanLIVE has established that the ITB has requested a further extension until the beginning of March because of the voluminous documentation filed, as well as the disruption caused by the festive period.

LRC lawyer Thabiso Mbhense confirmed to SowetanLIVE on Thursday that the ITB had requested an extension until March 1.



The Ingonyama Trust, whose sole trustee is the Zulu monarch, was established in 1994 to be the custodian of the land previously administered by the former KwaZulu-Natal government.

In their court application, Casac, the Rural Women's Rights Movement and seven informal land rights holders are challenging the conversion of Permission to Occupy (PTO) or informal land rights to long-term lease agreements by the trust. A number of people hold a PTO or informal land rights on land vested or registered under the Ingonyama Trust.

Two years ago, the trust published adverts in various newspapers in KwaZulu-Natal inviting holders of PTOs to approach the ITB "with a view to upgrading these PTOs into long-term leases in line with the Ingonyama Trust tenure policy".

The envisaged lease agreements would be for 40 years and could cost the occupier between R1,500 and R7,000, depending on the size of the plot of land.

But the applicants argued in court papers that the trust acted "unlawfully and in violation of the constitution" by cancelling PTOs and concluding lease agreements with the holders of PTOs or informal land rights.

Casac, through an affidavit filed by its secretary Lawson Naidoo, said since 2007 the trust and its board have been "undermining the security of tenure of residents and occupiers of trust-held land in KwaZulu-Natal".

It also emerged from the court application that the ITB and traditional leaders were forcing woman residents on land under its control to sign leases through male proxies.

In her affidavit, Rural Women's Movement chair Sizani Ngubane said: "I have also heard of cases where the ITB, or the inkosi, insists that the lease must be in the name of whatever man they find on the property, because they assume that a man must always be the household head. This creates great difficulties if the man is just a boyfriend of the woman who owns and has established the property."

The ITB, which has vowed it would oppose the application, did not respond to queries about the extension.

The trust has come under scrutiny after a high-level panel headed by former president Kgalema Motlanthe proposed the disbandment of the trust. Last year, parliament's portfolio committee on rural development and land reform also instructed the ITB to stop converting OTPs into leases.

The auditor-general also took issue with the ITB for failing to provide supporting documents to account for land to the value of R1.08bn. Last year it was ordered by the auditor-general to pay the Treasury millions of rands in mining royalties it has collected since 1994 which will now have to be paid into the national revenue fund.

But King Zwelithini has made it clear that any attempts by the government to tamper with tribal land under the trust would be met with resistance by his subjects.

Remember that your purpose is not to testify on behalf of anybody but simply to let the presiding officer know what you know.

- 1) Truth holds the highest value in life. Both science and justice call for us to seek and tell the truth, not to tell lies and spread error.
- 2) God has been scientifically proven as The Creator of all life. I believe in God.
- 3) The Bible contains The Word of The Almighty God Yahweh.
- 4) I believe that The Son of God, The Lion of The Tribe of Judah (known as Jesus Christ) is coming back to Earth in a physical body as a White man.
- 5) I have worked for Andre and Katarina for almost 4 years now; I like to work for Them even though They do not have a lot of money. My partner loves Andre and wants me to work for Him.
- 6) I do not feel that Andre and Katarina treat me like nothing. They reprimand or ignore me, but I have never felt hated in Their company.
- 7) Andre and Katarina do not display hate towards the neighbourhood; They have been very helpful and kind to the Local Black Community, and community likes Them.
- 8) Except for dogs and pigs, which God also hates, Andre and Katarina love animals very much. They even like animals I am scared of, like lizzards, snakes, frogs or bats.
- 9) I serve and love Andre and Katarina; I am an orphan, and They are like my parents. I can ask Them for help with anything, and I listen to Their guidance/advice.
- 10) Andre and Katarina grow their own vegetables and fruit and make their own food, including bread. When guests used to leave products from the shopping centre, They let us have it. However, They told me what I should not eat from that and that it was my choice.
- 11) Andre and Katarina are much more clever than me; they have taught me many new things. They spend most of their time reading.
- 12) Katarina can draw perfect pictures; I have not seen Blacks draw or paint like She does.
- 13) Andre can fix almost anything, and many neighbours admire Him.
- 14) The local high school asked Andre and Katarina to teach Mathematics and Physical Science as students had a problem learning it.



- 15) When Katarina was in prison, I visited Her together with my partner and another housemaid which used to work here; We all missed Her and were very happy to see Her. We bought Her and Andre some fruit as They had no money at that time.
- 16) When Katarina was in prison, Andre gave me a letter for the neighbourhood to sign to show they support Andre and Katarina. I came to ask for more papers as many more neighbours wanted to sign it.
- 17) Since the guesthouse was closed, almost no one visited here.
- 18) My family and the local "Induna" helped Andre and Katarina with food.
- 19) The Black community does not like iSimangaliso; they wanted to remove us from our houses but did not even speak to us about it. We are very angry with them.
- 20) The Black community cut part of the forest in The Park in a protest against iSimangaliso.
- 21) The Black community feels that iSimangaliso did nothing good for them.
- 22) I see big difference between Black and White mentality; for example, Blacks express themselves much louder and with more rythm, they litter more indiscriminately, they are much less punctual and hygienic, they are much more concerned with image, and they read much less than Whites.
- 23) Blacks call a White mulungu but also isilwane (meaning animal) because Whites are always with animals and look after them.
- 24) Black females love babies very much. We have babies very young, but we often do not get married.
- 25) There is widespread practice of witchcraft and ancestral beliefs amongst Blacks.
- 26) Black males in general drink a lot and are sexually uninhibited.
- 27) I like it when males are drunk, loud and horny.
- 28) Black females in general want to look like White women; they hate their hair and put on false hair instead, disrespecting themselves and God Almighty (1 Peter 3:3).
- 29) I prefer the company of Blacks as I relate to them better.



FYI: Witness Preparation (source: *Your Guide to the South African Equality Courts, 2015*)

There are two parts to witness testimony: (1) the witnesses' responses to your questions (direct examination), and (2) their responses to the opposing parties' questions (cross-examination). Unfortunately, many unprepared witnesses have enormous difficulty in responding to cross-examination and treat questions from the opposing party with hostility.

The reason for this is two-fold. First, they often believe that they are testifying on your behalf, and therefore tend to take sides. Secondly, they may view the opposing party as the enemy, and they may testify differently when you are asking the questions as opposed to when the other side is asking the questions. A change in demeanor of a witness tends to show bias to the presiding officer and needs to be avoided, so that the witness is viewed as neutral and reliable.

Preparing the Witness for direct and Cross-Examination Testimony

Tip 1: Explain that the witness's purpose is not to testify on behalf of anybody, but is simply to let the presiding officer know what the witness knows. In this regard, it is important that witnesses understand that they are not advocates, but simply people who have information that may be useful to the decision maker.

Tip 2: Explain to the witnesses that they should: (i) listen to each question carefully; (ii) answer only the question asked; and (iii) then be quiet and wait for the next question. The untrained witness tends to ramble and say things that are irrelevant, or worse, wrong.

Example:

An easy way to demonstrate this principle is to ask the witness "do you know what time it is?" Almost invariably the witness will look at his/her watch and say, "it is 9:30 a.m." This is the wrong answer. The question only calls for a "yes" or "no" answer. Had you wanted to know what time it was, you would have asked the question, "what time is it?"

This example helps witnesses understand that they answer only the question that is being asked and then remain quiet.

Tell witnesses that when they go beyond the scope of the direct answer to a question, whether it is from the complainant or the respondent, they open up a door that may allow for greater cross-examination than what was otherwise available. If they introduce new facts, the other party may be able to ask them about those facts. Additionally, the witness may say something that confuses the presiding officer. A good practice is to make sure you know everything the witness will say in response to prepared questions.

Tip 3: Make sure the witnesses understand that they must only testify about things they actually know, not about something that they assume is true.

Tip 4: Explain to the witnesses that they should never guess. A guess to a question can only have one of two results: the guess is correct or the guess is incorrect.

When the guess is incorrect, the witness will be made to look foolish if properly cross-examined. Explain that if the witness does not know the answer to a question, the proper answer is "I do not know."

Tip 5: Explain to the witnesses that they are to show the same respect to the other side's representative as they show to you. Being disrespectful to one side demonstrates a bias and weakens the testimony.



Tip 6: Advise the witnesses to look directly into the eyes of the presiding officer when they are testifying. When the witnesses are listening to questions, they can look at the person asking the question, but when testifying, they should look at the person whom you are trying to convince with the testimony.

....

The most important concepts for witnesses to remember are:

- ◆ do not take sides;
- ◆ listen carefully to the question being asked;
- ◆ answer only that question, then be quiet;
- ◆ never guess.

When schooled on these basic principles, witnesses can generally be relied on not to make unanticipated statements.

Applying these principles to our sample case...mr. Klein will testify about what he observed on January 1, 2012. You should explain to mr. Klein that he should only testify as to exactly what he observed, and he is not to serve as mr. masuku's advocate.

You should also advise him not to get hostile with the opposing counsel. Instead he should listen very carefully to the questions, and provide short, thoughtful and direct answers. 













From the neighbors of Sodwana Bay Guest House

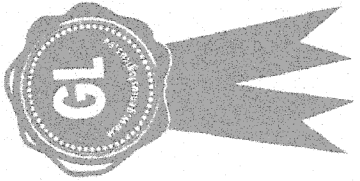
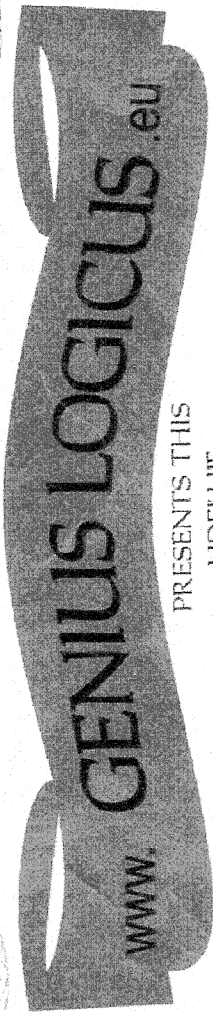

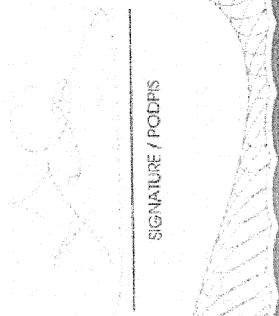

4. S.79 (4) (a) ENQUIRY:

4.1 PERIOD OF ENQUIRY:

An assessment was carried out complying with Regulation 46(1) & (2) of the Mental Health Care Act, No.17 of 2002, over a period 25/01/2017 to 15/2/17 in a special observation unit of the hospital by trained psychiatric personnel. Written reports on mental condition and behaviour were maintained and additional investigations done if indicated.

4.2 MEDICAL HISTORY AND FINDINGS:

No significant medical history reported. No history of any significant head trauma

4.3 MENTAL STATE - HISTORY AND FINDINGS:

No significant history of prior psychiatric treatment reported. The accused is from Slovakia and has been in South Africa since 2012. She speaks English and is able to answer questions. She denied any psychiatric symptoms and did not have any cognitive impairments. There were no signs of any mood disorder or disorganised speech. There were no signs of any substance withdrawal or intoxication.

She was not anxious and she was able to give her version of events. Her memory was intact. She was preoccupied with her religious beliefs which have been

present for the last few years since she has been in South Africa.

These beliefs are overvalued and cannot be substantiated. She did not have this belief system when she was in Slovakia. The accused feels her religious belief impact on the legal system in South Africa. This is an overvalued idea.

She is aware of the legal system in South Africa and issues that pertain to travel to other countries and immigration laws. She is not mentally ill and is able to appreciate the wrongfulness of her actions.

5. S.79(4)(b) DIAGNOSIS/MENTAL CONDITION

1. Not mentally ill
2. Overvalued religious ideas

6. S.79(4)(c) - IN TERMS OF SECTION 77(1)

The accused is able to follow court proceedings and give an account of herself. This is a personal choice to ignore the facts of her case and discuss the religious ideas. This is not a mental illness or mental defect.

7. S.79 (4)(d) - IN TERMS OF SECTION 78(2).

The accused is aware of wrongfulness of her actions and is able to differentiate right from wrong. Her religious belief system is not a lack of competency related to South African law.

8. RECOMMENDATION

It is respectfully recommended that the court appoint someone to contact the accused family in Slovakia to discuss the factors related to this case.

Why Bhagavad Gita should be compulsorily taught in Schools in India?

Should Bhagavad Gita be compulsorily taught in Schools in India?

The Bhagavad Gita has been inadvertently brought into the ambit of public discourse in the past few months. The question that has deeply divided opinions among various religious scholars, government and political parties is a very simple one. Should Bhagavad Gita be taught compulsorily to children in schools? This seemingly simple and innocuous suggestion has been made the subject of fiercely fought debates those who studies and learned Bhagavad Gita but not on national news channels. The media coverage around this issue has taken an inexplicable turn as it has been seen with conjunction to the idea of secularism. For the purpose of being objective and unbiased, let's try to answer the question in a purely logical way.

Noble Book Rich of Excellent Examples

As we all know, Bhagavad Gita is a Hindu scripture with 700 verses which forms a small part of the epic Mahabharata. Written in a narrative tone, the scripture is essentially an insightful and profound conversation between Lord Krishna and the Pandava prince, Arjuna. The text contains the counsel of Lord Krishna as he helps Arjuna to address a moral dilemma. It encompasses the answers to some of the most common trials and spiritual questions that a man faces throughout his life such as fulfillment of his/her duties, attainment of liberation and many more. "Seeing fathers-in-law, companions and all his kinsmen standing in the ranks of the two armies, Arjuna was overcome with great compassion and sorrowfully said, "O Krishna! Seeing my kinsmen standing with a desire to fight, my limbs fail and my mouth becomes dry. My body quivers and my hairs stand on end."

We have all been in a situation which makes us feel scared and nervous at the same time. We often tend to make a mess of these circumstances either due to inaction or because of haste. But if we imbibed the learning of Gita at a very young age in our minds, wouldn't it be much easier to tackle the uncertainties and challenges life throws our way. For instance, look at the answer to Arjuna's dilemma given by Lord Krishna in Chapter titled 'Path of Karma- Yoga'

“One does not attain freedom from the bondage of Karma by merely abstaining from work. No one attains perfection by merely giving up work. Because, no one can remain actionless even for a moment; everyone is driven to action – helplessly indeed, by the forces of nature.”

The wise should not unsettle the minds of the ignorant who are attached to the fruits of the work, but should inspire others by performing all works efficiently, without selfish attachment.”

Refrainment from the Goodness of Religious Knowledge

Universities from across the world such as Seton Hall University have made it mandatory for students to study the Bhagavad Gita. It’s ironical that top business management institutes are teaching Bhagavad Gita as part of their curriculum while India’s young generation remains deprived of its benefits.

God, The Divine Creator uses numbers to help us understand His creation; numerology or gematria is the ancient science of equating numbers with letters which works both ways: to hide and to uncover the hidden meanings of the words. In this document I only used Sumerian Numerology as this system comes from the Sumerians.

Nikola Tesla wished to enlighten humanity and saw ignorance as evil, the stumbling block:

"Of all the frictional resistances, the one that most retards human movement is ignorance, what Buddha called 'the greatest evil in the world.' The friction which results from ignorance can be reduced only by the spread of knowledge and the unification of the heterogeneous elements of humanity. No effort could be better spent.."

The Creator used Tesla in His Divine plan; he drew the world's attention to the numbers 3, 6 and 9:

**"If you only knew the magnificence of the 3, 6 and 9,

Tesla was greatly interested in this trio, but he also knew that he could not understand it himself:

"My brain is only a receiver, in the Universe there is a core from which 'We' obtain knowledge, strength and inspiration. I have not penetrated into the secrets of this core, but I know it exists."

"Now, I must tell you of a strange experience which bore fruit in my later life. We had a cold [snap] drier than even observed before. People walking in the snow left a luminous trail. [As I stroked] Mačak's back, [it became] a sheet of light and my hand produced a shower of sparks. My father remarked, this is nothing but electricity, the same thing you see on the trees in a storm. In its infancy the Tesla 369 code served as a confirmation to Andre, fueling His philosophy. 3: The number 3 represents the omni-present spiritual component of life.

The atom is the manifestation of The Holy Trinity, which is the union of the Neutron (Father), Proton (Son) and Electron (The Holy Spirit). The Aether is the proton-neutron framework which allows electron flow, the force behind everything. The number three also represents the home of Elohim, Orion's Belt also known as The Three Sisters.

6: The number 6 represents the physical component of life, the matter.

Life energy in everything is the result of the "void" which is the force behind the carbon manifestation of matter and life. Carbon 12 is The Creator's autographed building block; He left the signature 666 in it in a form of 6 neutrons, 6 protons and 6 electrons. Number 18 represents life

Let Me explain resonance as simply and as well as I can right now; resonance, synchronicity is a two-way circular communication between all life forms. The concept of resonance applies to everything in the Universe and brings harmony.

When you pray to Almighty God YAHWEH and He answers you, it is resonance.

Frequency can resonate or dissonate with humanity; resonance is the cosmological principle of stimulus and response between things of the same kind. Multiples of a certain number are connected to it and to each other and therefore work in Unison.

The frequency of 432 Hz is healing for creatures of Earth because earthly bodies resonate with it. This natural peaceful frequency was changed to energetically disruptive frequency of 440 Hz. All great ancient civilisations and musicians tuned their instruments to the base frequency of 432 Hz; Sumerians or Egyptians, Mozart, Bach, Chopin, Debussy or Vivaldi were tuned to Nature. "Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is Six hundred threescore and six."

The number 37 is the manifestation of God's absolute power; it is the mark of God: **26 + 11 = 37**.

Multiply number 37 by the magnificent 3, 6, and 9, and you will get number 666

3 x 37 = 111

6 x 37 = 222

9 x 37 = 333

Add the right side to the left side of 37, and you will get **1**
 Add the right side of 37 to it and you will get **44**
 Add the left side of 37 to it and you will get **40**
 Multiply 3 x 7 and you will get 21 = **777**
 Add 37 to its opposite number 73, and you will get **110**
 Go from 37 to 73, and exactly in the middle you will get **55**

Research the number 37, and you will see that it is truly divine. This is the number of Elohim. Elohim is the original Hebrew word used in *Genesis* describing the Creators of Man; it is a plural form referring to both male and female and is none other than The Son of God, Christ and The Holy Spirit, Sophia. 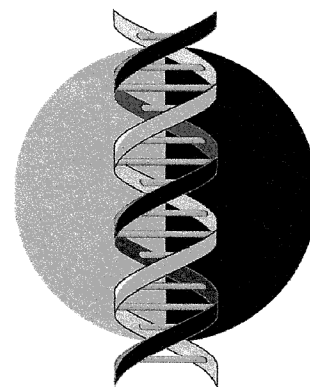
